



COMMENTS

Adult occupant: The car just managed to achieve 4 stars. In the frontal impact the driver head was well protected and passenger head was close to contact with the dashboard. The chests showed marginal protection from the restraint systems. There were hazardous structures in the area of the facia that could be impacted by the driver and front passenger knees. The car does not have SBR. The vehicle bodyshell was rated as unstable.

COMMENTS

Child occupant: The child seat for the 3 year old child was unable to prevent excessive forward movement during the impact and offered low protection to neck and chest. The dynamic performance of the 18 months child restraint offered good protection. Most of the CRS that were assessed for installation pass considering the exempted positions in the manual. The car does not have warning marking for installing a CRS in the front passenger seat and it is not possible to disconnect the passenger airbag in versions with 2 airbags.
