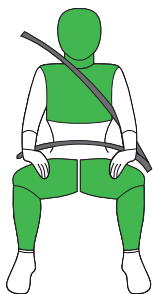

COMMENTS

Adult occupant: - In the frontal impact the driver and passenger heads were both well protected by the driver and passenger airbags. Both seatbelts were equipped with pretensioners and load limiters. The driver and passenger knees areas did not show critical structures. The bodysell was rated as stable and was capable of withstanding further loading. The model could meet the requirements of the UN95 side impact test.

COMMENTS

Child occupant: - The child seat for the 3 year old child was able to prevent excessive forward movement during the impact and offered good protection. The dynamic performance of the 18 months child restraint was good. Most of the belted CRS that were assessed for installation pass considering the exempted positions in the manual. The car has warning marking and allows passenger airbag disconnection for installing a CRS in the front passenger seat meeting Latin NCAP requirements.
